Dear Sir/Madam,

As you may be aware, the Mt Joyce Escape Recreation Park (**Park**) is now under the management of Seqwater.

As a means to provide a recreational area for the general public, Seqwater has appointed BBS Communications Group as an independent facilitator to establish a company limited by guarantee (**Management Company**) to effectively manage the various recreational pursuits of the Park as trustee of the Mt Joyce Escape Recreation Park Trust (**Trust**).

BBS is now seeking Expressions of Interest for individuals to nominate for the positions of director, company secretary or public officer of the Management Company.

The Park is being developed as part of the Wyaralong Dam project and consists of over 40km of multi-use trails, up to 25km of dedicated mountain bike trails, trail heads, camping facilities, picnic and playground amenities.

Submissions from park user groups are encouraged to ensure there is a cross section of recreation, business and community interest groups represented on the Management Company.

The role of the Management Company will include:

- Managing the Trust;
- Regulating various uses of the park in a fair and consistent manner;
- Ensuring compliance with the approved Recreation Master Plan and maintenance and management plans applicable to the Park;
- Ensuring protection of biodiversity, scenic amenity, cultural heritage and other landscape values within and adjacent to the Park;
- Minimising damage to the Park and its facilities and establish uniform standards for the upkeep and restoration of the Park;
- Helping ensure the Park becomes self-sustaining in the long to medium term; and
- Allowing permits and licences or secondary uses and manage the transfer of tenure rights, where appropriate, through the use of legal mechanisms.

We are currently seeking Expressions of Interest for the following positions:

- Directors of the Management Company;
- One company secretary of the Management Company; and
- One public officer of the Management Company.
